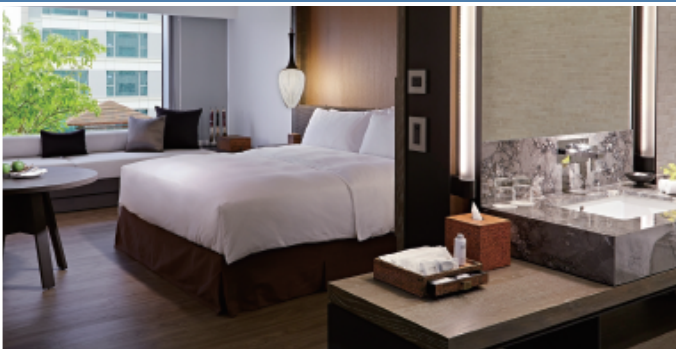

Terms and Conditions

1. Please complete the online application and provide relevant information about the artist (Name, Medium, Year of Birth, Nationality) and artwork (Name, Medium, Size, Year of Creation) for evaluation. Please provide the exact artworks to be used in the catalogue and exhibited at the fair.
2. The Executive Committee will evaluate the gallery's application and artist information.
3. The selection is conducted by the Executive Committee. Applicants shall guarantee that all the information provided in the application is accurate and will not be changed without the permission of the Executive Committee. The Executive Committee reserves the right to cancel the participation if the exhibitor fails to follow the terms.
4. Exhibition room shall not be changed or transferred to another exhibitor. **Any display and commercial activity of artworks outside the exhibition room are prohibited. The Executive Committee reserves the right to cancel the participation and will not accept the application in the future if the exhibitors fail to follow the terms.**
5. Applicants shall guarantee that all artworks submitted are authentic. The Executive Committee reserves the right to cancel the participation if the exhibitors fail to follow the terms.
6. Art crafts and antiques are not accepted for exhibition during the fair. The derivative products of participating artists are not subject to this restriction.
7. The Executive Committee will carefully review the information provided by applicants; the selection result will be announced on January 5th, 2026. Exhibitors shall follow the payment instructions upon receiving the admission to proceed with their participation in ART TAINAN 2026.

Regulation and Guidelines

1. Exhibitors shall open the exhibition room by 13:30 PM on VIP preview and by 11:50 AM the rest of morning during the fair. Any delay or early closure of the exhibition time is not allowed.
2. Except the public exhibition space allocated by the Executive Committee, exhibitors shall present the artworks only in the exhibition room. **It is prohibited to place any personal items, flower baskets, wreaths, potted flowers, artworks, promotional materials at any public space, including aisles and stairwells.**
3. All exhibitors shall cover their own insurance for the artworks from the first day of installation until the end of dismantling. **The Executive Committee and the hotel will not be responsible for any loss or damage to exhibitors.**
4. From the first day of installation until the end of dismantling, exhibitors shall wear the Exhibitor Pass or Installation/ Dismantling Pass to enter the exhibition venue.
5. If any artwork needs to be taken out from the venue, **please fill out the “Artwork Release Form” and bring it to the Exhibitor Service Counter for stamping, so that the artwork can be released from the exhibition.**
6. The Executive Committee is solely responsible for Public Liability Insurance during the fair. All exhibitors must follow the safety principles and self-insure the cost of damage, loss, theft, robbery, fire, water damage, transportation and other situations. In any case or scenario, the Executive Committee is not responsible for the damage of the artworks, nor for the equipment. All exhibitors must compensate for damage caused by the equipment or related to the staff, other exhibitors, visitors, etc. The Executive Committee has no obligation to exhibitors for direct or indirect damages of artworks.
7. Exhibitors shall solely proceed with installation or dismantling within the time appointed by the Executive Committee.

Important Notice for the Usage of Exhibition Space

1. It is required that at least one staff of the Exhibitor stays in the exhibition room at all times during the opening hours and cleaning time.
2. Any share of the exhibition room is not allowed.
3. Exhibitors shall install the room according to the exhibitor’s manual. Please do not drill or nail the wall and do not damage the wallpaper, furniture and equipment. The hotel staff will examine the room at the time of check-in and check-out. If there is any activity causing damage, exhibitors shall compensate the losses and the cost to Silks PLACE TAINAN Hotel.
4. Please do not move large furniture or remove the bathroom door without permission of the Organizer or Silks PLACE TAINAN Hotel. Violators need to compensate the hotel for the losses.

5. In order to avoid electrical hazards or blackouts, please do not exceed the maximum usage of electricity of the hotel room: max. 5 amps for each circuit, and max. 2 circuits with a total of 10 amps.
6. Exhibitors shall dismantle and clean up the room according to the exhibitor's manual. If there is any damage caused, exhibitors shall compensate the losses and the cost to the Organizer.
7. It is not allowed to smoke in the exhibition venue or bring dangerous goods into the exhibition venue.
8. Exhibitors are not allowed to post or hang works and promotional material on their room door and in the public area outside their room. The committee reserves the right to ask violators to remove the posters.

Force Majeure

In the presence of any third-party default, accidental happening, safety issues, public health concerns or political events that seriously affect the normal operation of the exhibition, the Organizer has the right to postpone the event or to shorten its duration. In all such cases, the exhibitors will not be entitled to claim any refund or compensation.
